Transport Permit Conditions

- 1. If the manufactured home is permanently placed on a location other than specifically described on the transport permit, the owner must advise the Registrar and provide full details of the location either
 - (a) within 3 days after the manufactured home was transported to the new location or
 - (b) within 3 days after the expiration of the transport permit which ever occurs first.
- 2. This permit expires 30 days after the date of issue. If the manufactured home is NOT MOVED within this time, you must report the physical location of the manufactured home within 3 days after the expiration of the permit.
- 3. This permit may be used for one (1) move only. A new permit must be obtained for subsequent moves.
- 4. Upon leaving British Columbia, this home is Exempted from the Manufactured Home Act. The home is required to be re-registered under the same number if it re-enters the Province of British Columbia.
